Whether you are a member of the business community or an educator, we can all agree that every Virginia public school student should receive an education that prepares them for the 21st century world and workforce – regardless of their income, race, or zip code," said John Asbury, Chair of Virginia Learns Governing Board and CEO of Atlantic Union Bank.

As part of its commitment to supporting what works in the classroom, Virginia Learns is partnering with the Commonwealth Learning Partnership, a collective of more than forty state

and local education organizations, membership groups, schools of education, and individual educators who share the mission of upskilling Virginia's educator workforce and preparing students for post-academic success.
